Going forward, Dentsu Plus will develop and provide a range of enhanced services through its new "Brandscape Division" and will aim at expanding its business even further through its positioning as an advertising company that is different from what it has been to date.

Brandscape President Dolchai Boonyaratavej, who guided his company through the challenges of the business of branding in Thailand, has been named Chairman of Dentsu Plus while its former Managing Director Takemi Furuta has been appointed President and CEO of the company.

The impact of this transaction on Dentsu's consolidated financial results for the fiscal year ending March 31, 2014 is expected to be minimal.
