Dentsu Announces Acquisition by Dentsu Aegis Network of Leading PR Agency Perfect Relations in India

Dentsu Inc. (Tokyo: 4324; ISIN: JP3551520004; President & CEO: Tadashi Ishii; Head Office: Tokyo; Capital: 74,609.81 million yen) announced today that its global business headquarters Dentsu Aegis Network Ltd. has acquired leading public relations (PR) agency Perfect Relations Pvt. Ltd. (Group CEO: Pradeep Kewalramani; Group Managing Director: Dilip Cherian; Head Office: New Delhi; hereinafter "Perfect Relations") and five other agencies known collectively as the Perfect Relations Group.
