### **Dentsu Announces Prospective Executive Officers**

(Tokyo: 4324; ISIN: JP3551520004; President & CEO: Toshihiro Yamamoto; Head Office: Tokyo; Capital: 74,609.81 million yen) today convened a meeting of its Board of Directors at its Head Office in Tokyo to select its Executive Officers, which will become effective on January 1, 2018, as follows.

#### 1. Incoming Executive Officers
